


COVID CASES IN THE US





COVID CASES BY STATE






COVID CASES – LTC FACILITIES





COVID-19 VACCINATION TRENDS AND CMS MANDATES




- May 2021: New regulations regarding education for residents, clients, and staff. Weekly reporting of COVID-19 vaccination data for residents and staff to the CDC
- August 8, 2021: Nationally 62% of nursing home staff are currently vaccinated and vaccination among staff at the state level ranges from a high of 88% to a low of 44%
- August 18, 2021: CMS in collaboration with the CDC, developed an emergency regulation requiring staff vaccinations for more than 15,000 Medicare and Medicaid-participating nursing homes
- September 9, 2021: Vaccines mandated for all private-sector employees, health care workers and federal contractors

VACCINATION STATUS BY STATE - LTC

This shows how many doses of vaccine have been given to residents and staff in long-term care facilities.

PUBLIC READINESS & EMERGENCY PREPAREDNESS ACT



- Enacted by congress in 2005
- Authorizes the Secretary of the US Department of HHS to issue a declaration in response to a public health emergency
- Provides expansive immunities from liability to certain "covered persons" for taking certain "covered countermeasures" necessary to combat a public health emergency



PUBLIC READINESS & EMERGENCY PREPAREDNESS ACT



Covid-19

- March 17, 2020: Declaration by DHHS triggered PREP act protections retroactive to March 4, 2020
- March 24, 2020: DHHS Secretary sent letter to Governors calling for them to develop a list of state liability protections
- August 4, 2021 HHS Secretary issued 8th amendment covering pharmacy technicians and interns to administer flu and covid vaccines / therapeutics
- September 14, 2021 9th amendment set to be published
- Liability protections extend through the final day of the Declaration of Emergency or October 1, 2024, whichever occurs first \square

PUBLIC READINESS EMERGENCY PREPAREDNESS ACT



- Immunity includes:
 - Any claim, under federal or state law, for loss that has a causal relation with the administration to or use by an individual covered by a countermeasure
 - Loss includes: death, personal injury, emotion injury, property damage, business interruption and fear of personal injury
 - Protection is very broad and applies "without regard to the date of the occurrence, presentation or discovery of loss"
 - *Does not cover willful misconduct



EXAMPLE: IMMUNITY PROVIDED IN PENNSYLVANIA



- May 6, 2020
 - Governor Tom Wolf issued an Executive Order providing civil liability immunity to health care provider for good faith actions taken in response to the Covid-19 health emergency.
 - The order does not extend to care and treatment of non-Covid patients.
 - The order does not extend to Nursing Homes



EXAMPLE: IMMUNITY PROVIDED IN PENNSYLVANIA



- November 20, 2020
 - House bill 1737 passed the Pennsylvania House and Senate.
 - Offers protections to long-term facilities and hospitals, from being held civilly liable from damages related to COVID-19 outcomes unless there's "clear and convincing evidence of gross negligence, recklessness, willful misconduct or intentional infliction of harm."







- December 1, 2020
 - Governor Tom Wolf vetoed Bill 1737
 - Stating the legislation would undermine COVID-19 mitigation efforts and endanger public health.
 - Measure would have provided "broad, overreaching immunity from civil liability."
 - "Shielding entities from liability in such a broad fashion as provided under this bill invites the potential for carelessness and a disregard for public safety,"





- April 6, 2021
 - House of representatives bill to protect healthcare workers, businesses, health care facilities, nursing homes and schools
 - Falls short of blanket immunity and those covered will still have to follow all guidelines.
 - Pennsylvania Health Care Association supported bill
 - "Businesses that did their best to provide essential goods and services should not have to worry about costly litigation"



LITIGATION LANDSCAPE

ANTICIPATING FUTURE COVID CLAIMS



- Failure to prevent / mitigate the spread of Covid-19
- Failure to recognize a change in condition related to Covid infection
- Failure to notify family and/or physician of Covid related issues
- Delay in treatment
- Failure to prevent asymptomatic workers from spreading the virus
- Inadequate staffing
- Inadequate or inappropriate use of PPE
- Negligent infection control practices
- Failure to follow local and/or federal guidance
- Negligent treatment of non-Covid patients including delays in treatments and/or surgeries



CLAIM / LITIGATION LANDSCAPE



- Key Time Period
 - Originally March 2020 October 2020
 - Now this time period has been extended with new guidance ...
- COVID-19 not directly mentioned in a claim or letter of intent



THE 'INTENTION' OF THE MEDICAL RECORD



- Concurrent
 - Communication between providers



Record of care provided

- After the 'infection'
 - Evidence in legal forums








DOCUMENTATION BEST PRACTICES



- Complete and well organized medical records
 - Notations in records of facility status at that time
- When residents / patients were first diagnosed and treated
 - Who was notified and when
- Staff training and meetings, update to staffing plans
- Policy changes responsive to state / federal guidance
- Infection control policies, procedures and updates
- Emergency response plan
 - When and how it was implemented





DOCUMENTATION BEST PRACTICES



- Supply chain evidence
- Efforts to obtain and provide PPE Masks, gowns, hand sanitizers, etc.
 - Track costs of PPE
 - Invoices
 - Manufacturers numbers
- Efforts to acquire and administer Covid tests
- Practice changes
 - Visitation restrictions
 - Testing protocols and records
 - Social distancing and isolation measures





DOCUMENTATION BEST PRACTICES



- Memorialize your story
 - What did you know
 - When did you know it
 - What did you do
 - What was happening at the time
 - The experiences of your care-givers
 - Their heroic work
 - Videos
 - Articles
 - Patient / resident / family / community acknowledgements


